Any such items are not covered by this Limited Warranty. Subject to the limitations and exclusions found in this Limited Warranty and Disclaimer, Bald Technologies, LLC warrants that Products, for the period set forth below, purchased and installed in this United States and Canada are free from material defects in material and workmanship.

2. <u>PURCHASER'S RESPONSIBILITY</u>: In order for this Limited Warranty to apply, the purchaser of Product(s) (the "Purchaser") must use the Product in accordance with the instructions for use provided at www.bullybrakes.com.
